[Allowing Foreign Entities to Influence Ballot Initiatives with Campaign Contributions]

We are now going to focus on state and local ballot initiatives.

As you may know, a ballot initiative is a question put on a ballot that asks voters to decide for or against a specific proposal. If a majority of voters favor the initiative, it then becomes law.

Currently, there is a debate about the fact that there are no federal limits on who can spend money to try to influence the campaigns for or against a ballot initiative, such as contributing to a campaign or paying for advertising. Several states have passed laws to prohibit such contributions.

There is a proposal in Congress to create a federal law that would prohibit foreign individuals, companies, or governments from spending money in an effort to influence the outcome of a ballot initiative.¹

Here is an argument in favor:2

Q31. The American government is supposed to be ruled by and for American citizens. Allowing foreign businesses and governments to use their money to influence our votes on ballot initiatives violates this principle. This is why we made it illegal for foreigners to spend money to influence our elections. For example, a city trying to vote on a local project to ban the use of certain polluting chemicals should not have to worry about the foreign corporation that makes those chemicals spending millions to influence the outcome just so they can keep selling their polluting chemicals.
